FOR FISCAL YEAR 1998-1999**



1. During JEA's fiscal year commencing September 30, 1999, there were no customers transferred by and between the parties to the Territorial Agreement.
2. For the time frame from October 26, 1992, when the Territorial Agreement was adopted, through September 30, 1999, a total of 3,827 customers were transferred from Clay to JEA and a total of 4,540 customers were transferred from JEA to Clay.
