CATV Limited Partnership d/b/a CableVision Communications to Interlink Communications  
Partnership, LLC d/b/a Charter Communications, Inc.

Communications is a telecommunications company authorized to provide shared tenant services

A description of the parties and the relevant transactions are provided below. An original and twelve copies of this letter are enclosed. Please date stamp the enclosed extra copy of this filing and return the same to the undersigned.

#### **THE PARTIES AND THE TRANSACTION**

On or about July 1, 1999, Rifkin/Narragansett CATV Limited Partnership, a Florida limited partnership doing business as CableVision Communications, was dissolved. Contemporaneous with the dissolution of the Rifkin/Narragansett Limited Partnership, Interlink Communications Partnership, LLC was formed as a Florida limited liability corporation. Interlink did business as CableVision Communications. Under the new Interlink Communications Partnership limited liability company, a number of telecommunications systems were purchased and operated, including the Rifkin/Narragansett shared tenant service operations in Dade County, Florida.

Subsequently, on September 14, 1999, all controlling ownership interests in Interlink were purchased by Charter Communications, Inc., a Delaware corporation authorized to conduct business in Florida; however, the legal entity retaining ownership and conducting operations of the telecommunications facilities remained Interlink although the d/b/a was changed from CableVision Communications to Charter Communications, Inc.


The purchase and sale of the assets and controlling ownership interests in the former Rifkin/Narragansett CATV Limited Partnership by Interlink d/b/a Charter Communications, Inc. has been transparent to the affected shared tenant services customers. The transactions have not involved any change in the manner in which the companies provided or continue to provide telecommunications services to the affected customers.
