This will confirm our conversation of April 17, 2000 concerning the motions filed by Staff on April 17, 2000 in the above captioned matter.

BellSouth does not object to Staff's Motion for Leave to File Direct Testimony Out of Time so long as BellSouth and the other parties have an opportunity to file rebuttal testimony.




