Dear Mr. Cogen:

This docket was opened because the 1998 regulatory assessment fee (RAF) had not been paid. Our records show that you responded to Order No. PSC-00-0522-PAA-TI, which was issued on March 10, 2000, by paying the 1999 RAF and advising that you did not want the certificate cancelled. However, our records show that the 1998 past due charges remain unpaid.

Even though your certificate did not become effective until December 5, 1998, the RAF is due on each certificate if it is active for any day during a calendar year. I have enclosed the 1998 RAF form, which should be completed and returned, along with accrued penalty and interest charges..
