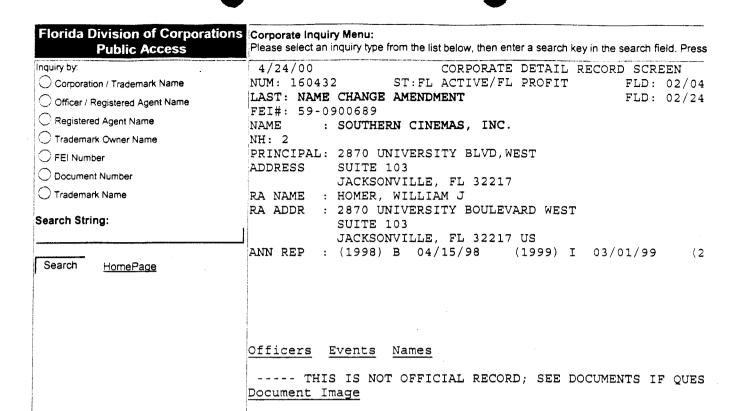

#### ARTICLES OF INCORPORATION

OF

ARTICLE I of the Articles of Incorporation ENTERPRISES, INC. is hereby amended to read as follows:

### "ARTICLE I

The name of the corporation is SOUTHERN CINEMAS, INC. The principal place of business is 2870 University Boulevard, West, Suite 103, Jacksonville, Florida 32217.
