
I am writing this letter in reference to Docket No. 992001-TX for The Mobile Phone Company failing to pay the regulatory assessment fee for 1998. In February of 1999, I was put in charge of the ALEC department unaware that a yearly fee was required. When I received a letter in February of 2000 requesting the fee for 1999, I immediately requested to have a check sent to pay for 1999 not knowing that 1998 had never been paid. Our ALEC certificate became active on December 5, 1998, and as I was told by one of your representatives, regulatory assessment fees are due even if the certificate was active for only one day in 1998. I realize that it is my responsibility to learn these rules and laws. I can assure you that now that I am aware of the required fees, not only will I make sure these are paid, but I will also correct the previous error by training any person that may replace me in the future.

The total amount due for 1998 is \$70.50, which has been enclosed in this letter with the appropriate return form.

I have also been made aware of a fine that is imposed with this rule violation and hope that you will consider the circumstances and reduce the fine to \$50.

Thank you very much for your consideration and again my apologies for the inconvenience it has caused.
