


**Application to Cancel

NOW COMES Long Distance International, Inc. ("LDI") an in support of it's Application to cancel it's Certificate of Public Convenience and Necessity states the following:

1. On October 7, 1994, in Docket No. 94-0900-TI, LDI was issued a Certificate of Public Convenience and Necessity ("Certificate") to provide interexchange telecommunications service which Certificate was numbered 3540.
2. Due to a change in the business direction of the Company LDI no longer seeks to be a provider of interexchange telecommunications services within the State of Florida.
3. LDI ceased marketing and has not provided service to any customers within the State of Florida for over a year. As a result, cancellation of LDI's Certificate is reasonable and would not be unduly disruptive to the present or future public convenience.

I had written the company 5/15 and advised they owed \$121.01 if they owed the minimum due, broken down as follows:

\$100.00 - RAF  
\$17.51 - penalty  
\$3.50 - interest

1994 - \$5.00 penalty and \$1.00 interest  
1995 - \$2.51 penalty and \$.50 interest  
1999 - \$50 RAF, \$10.00 penalty, and \$2.00 interest  
2000 - \$50 RAF

HOWEVER, I just noted in the RAF system that on 5/10, the company paid all of the 1999 RAF except \$.29 RAF, \$4.46 penalty, and \$.01 interest. I would like to point out that this 5/10 payment was not posted in the RAF database when I wrote the company on 5/15. This means that everything changes. I would apply the \$121.00 as follows:

\$107.52 - RAF  
\$11.97 - penalty  
\$1.51 - interest

1994 - \$5.00 penalty; \$1.00 interest  
1995 - \$2.51 penalty; \$.50 interest  
1999 - \$.29 RAF; \$4.46 penalty; \$.01 interest  
2000 - \$107.23 RAF

Dear Mr. Nowalsky:

This is in response to your letter dated May 8, 2000, in which you requested cancellation of Long Distance International, Inc.'s IXC Certificate No. 3540. Before I can recommend voluntary cancellation of a certificate, the company must be in good standing with the Commission and cannot have a past due balance of the regulatory assessment fees.

In this case, the company has a past due penalty and interest balance of \$6.00 from 1994 and \$3.01 from 1995. Also, the 1999 fee, plus penalty and interest charges, has not been received. In addition to the above outstanding balances, the company will also owe the 2000 fee. The 2000 fee will become due January 30, 2001. The company has the option of paying the 2000 fee when the past due amount is paid, or providing the Commission with a date certain when it will be paid.

Until the past due amount and information concerning the 2000 fee is received, I cannot proceed with your request for voluntary cancellation of Long Distance International's certificate.
