Pursuant to the Second Revised Order on Procedure, Order No. PSC-00-0540-PCO-TP, dated March 16, 2000, BellSouth Telecommunications, Inc. filed on April 17, 2000, its Incumbent Local Exchange Carrier recurring and non-recurring cost studies for Hearing #1. These cost studies were copied on 3 separate CDs labeled BSTLM - Loop Model (1 of 3, 2 of 3 and 3 of 3). Subsequent to the filing, BellSouth has determined that one of the CDs (1 of 3) contains an erroneous file. BellSouth is now filing a separate diskette to correct the erroneous file originally contained on the BSTLM - Loop Model.
