Sprint requests deferral of Item No. 25 on the May 16, 2000 Agenda Conference. The item involves Staff's recommendation regarding refunding surcharge monies to customers, including interest. Sprint and Staff had agreed on an interest number based on an established overcharge amount. In the past week, Sprint discovered a very small amount of additional overcharges and has asked Staff to calculate a revised interest amount. Staff has indicated that the interest calculation may take an additional amount of time. In the interest of getting the total refund amount right, Sprint requests a deferral for one agenda in order that the correct interest amount can be incorporated into the Commission's consideration. Sprint has discussed this with Staff and they concur.
