Dear Ms. Bayo:

Enclosed for filing on behalf of DURO Communications, Inc. ("DURO") are an original and fifteen copies of this letter requesting that the Commission defer final action in this docket for a period of thirty (30) days. There is nothing in the proposed agency action order issued April 28, 2000 in this docket (Order No. PSC-00-0844-PAA-TX) which states, implies or provides notice that any form of action is proposed to be taken by the Commission against DURO. Nonetheless, in a separate docket, Docket No. 000227-TX, the Commission has initiated a show cause proceeding against InternetU, Inc., a certificated alternative local exchange company ("ALEC") for failure to respond to a Commission staff inquiry. The Commission mailed a copy of the Order to Show Cause in Docket No. 000227-TX to DURO. DURO timely filed a letter in Docket No. 000227-TX advising the Commission that it does not hold any interest in the ALEC certificate granted by the Commission to InternetU, Inc. and, therefore, DURO was neither the proper recipient of nor responsible for the show cause order directed to InternetU, Inc. Staff has followed up on this issue by sending a data request to DURO. DURO intends to respond to the staff data request and will need a reasonable period of time to resolve this matter with the Commission staff.


