CLAIM OF CONFIDENTIALITY


On April 11, 2000 the Staff of the Florida Public Service Commission requested telephone number

utilization from Sprint in conjunction with an ongoing review of number resources in Docket No. 981444-TL.

Under separate cover Sprint has submitted a highlighted copy of the data request response containing information that Sprint claims to be confidential pursuant to Section 364.183, Florida Statutes. Although a claim of confidentiality is sufficient under the statute because the information is provided pursuant to the Commission's request, as information, the basis for Sprint's claim is that the highlighted information constitutes trade secret(s) and is competitively valuable information, the release of which would harm Sprint's competitive status. Because the entire response is considered confidential, a redacted copy of the same work papers is not being provided for inclusion in the Commission's files subject to public inspection.

This Notice and Claim requires that the information be treated as confidential while on file at the Florida Public Service Commission and further that the information be returned as required by Section 364.183, Fla. Stat.
