CoreComm Florida ("CoreComm FL") by its attorneys, respectfully submits an original and fifteen (15) copies of this letter in response to the May 23, 2000 letter we received from the Division of Records and Reporting of the Florida Public Service Commission ("Commission") in the above-referenced docket. We would like to clarify two points for the record.

First, CoreComm FL and ATX Telecommunications Services, Inc. ("ATX") did not file a request for approval of the proposed merger of ATX and CoreComm Limited. Rather, the parties filed a notification letter, based on our understanding of the law. Please inform us if a more formal application is necessary for the type of transaction that is being proposed.

Second, the Division of Records and Reporting's May 23, 2000 letter misstates the details of the proposed transaction. Ownership and control of ATX is not being transferred to CoreComm FL. Rather, ATX is being transferred to CoreComm Limited, the ultimate parent of CoreComm FL. As noted in the parties's May 18, 2000 letter to the Commission, the transaction is taking place at the parent level will not involve a change in the name of any of the operating companies currently providing service in Florida.
