**Withdrawal of Joint Motion for Continuance**

The Citizens of Florida (Citizens) file this withdrawal of the joint motion for continuance filed on June 7, 2000, and state the following:

Order No. PSC-00-0869-PCO-TL was issued on May 2, 2000 establishing the controlling dates for this hearing including testimony and hearing dates. On May 17, 2000, the parties filed a joint motion seeking modification of the Staff's testimony date. That motion was granted by Order No. PSC-00-1020-PCO-TL. On June 2, 2000 the testimony dates were further modified by Order No. PSC-00-1055-PCO-TL. On June 7, 2000, the parties jointly moved for a continuance of the hearing and other controlling dates in this docket.

Citizens now believe there is no more reason to delay these proceedings. Citizens therefore withdraw from the joint motion to continue the hearing filed on

June 7, 2000, and seek to proceed with the hearing schedule as expeditiously as possible.


