
STATEMENT OF JUDICIAL ACTS TO BE REVIEWED

Pursuant to Rule 9.200 (a)(3), Florida Rules of Appellate Procedure, the Florida Industrial Users Group (FIPUG) has directed the Clerk to transmit less than the entire record to the Court. Therefore, FIPUG files this Statement of Judicial Acts to be Reviewed. As the following reflects, FIPUG is appealing the Florida Public Service Commission's determination that ratepayers are responsible for the additional fuel costs incurred as a result of an explosion caused by TECo's employees. In Order No. PSC-99-2512-FOF-EI, the Commission declined to disallow replacement fuel costs for Tampa Electric Company (TECo), which were incurred due to an explosion at TECo's Gannon power plant. Even though TECo employees were responsible for the explosion, the Commission ordered that the ratepayers bear the responsibility for this additional fuel cost.


