America One Communications, Inc. ("America One") and PNG Telecommunications, Inc. ("PNG") hereby inform the Commission that the transfer of customer base, which the Commission approved on May 16, 2000, pursuant to its waiver of the requirements set forth in 25-4.11 F.A.C. regarding interexchange carrier selection has been completed.

In addition, America One requests cancellation of its certification to provide interexchange telecommunications service within the state of Florida. Since America One transferred its customers to PNG, America One is no longer providing interexchange telecommunications services to any Florida customer and has no current plans to provide any interexchange telecommunications services within the state of Florida in the foreseeable future. Therefore, cancellation of America One's certification will not impact Florida consumers.
