**RESOLUTION NO. 2000 - 97**

A RESOLUTION EXPRESSING A DESIRE FOR THE FLORIDA PUBLIC SERVICE COMMISSION TO APPROVE A SINGLE AREA CODE FOR ALL OF VOLUSIA COUNTY AND TO DESIGNATE 386 (FUN) AS THE NEW AREA CODE TO REPLACE 904 AND 407 IN VOLUSIA COUNTY; AND SETTING FORTH AN EFFECTIVE DATE.

**WHEREAS**, the explosive growth in telecommunications rapidly is exhausting telephone area code numbers; and

**WHEREAS**, it is clear that the 904 area code applies to the greatest majority of telephone subscribers in Volusia County; the area is expected to run out of numbers and the City of Ormond Beach City Commission expects the replacement of the 904 area code; and

**WHEREAS**, Volusia County, with its sparkling beaches and endless other leisure activities, is world famous as a FUN place to live and visit, now therefore,

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF ORMOND BEACH, FLORIDA, THAT:**

**SECTION ONE.** The City Commission affirms its position that there should be a single, new area code for all telecommunications subscribers in Volusia County.

**SECTION TWO.** The new area code should be designated as 386 (FUN).

**SECTION THREE.** This Resolution shall take effect immediately upon its adoption.


