Re: Notification of Name Change of UniDial Telecommunications LLC to Lightyear Telecommunications LLC

Dear Ms. Bayo:

On behalf of UniDial Telecommunications LLC ("Uni-Tel" or "Company"), this letter is to notify the Florida Public Service Commission ("Commission") of the Company's intention to change its name to Lightyear Telecommunications LLC. A copy of the Amended Certificate of Authority to Transact Business in the State of Florida is attached hereto as Exhibit A.

By way of background, Uni-Tel is authorized to provide interexchange telecommunications services in the State of Florida pursuant to Certificate No. 3960 issued by Commission Order No. PSC-94-1549-FOF-TI in Docket No. 940923-TI, on January 5, 1995.¹ Including Florida, Uni-Tel is authorized to provide resold intrastate interexchange and/or local exchange telecommunications services in 38 states, pursuant to certification, registration, or (where appropriate) deregulation. Uni-Tel is also authorized by the Federal Communications Commission ("FCC") to provide resold and facilities-based international message telecommunications services between the United States and various international points.

Uni-Tel has determined that the name change from UniDial Telecommunications LLC to Lightyear Telecommunications LLC will be a valuable step in developing the Company's telecommunications services and in implementing its ongoing business plan. The name change will



not in any way inconvenience or cause harm to Uni-Tel customers. Attached hereto as Exhibit B are tariff labels for Uni-Tel's revised tariff reflecting a name change to Lightyear Telecommunications LLC. Uni-Tel will notify customers of the name change by bill insert or other method. Consumers will continue to be provided high quality, affordable services by Lightyear Telecommunications LLC.

Upon review of Florida statutes and Commission rules, it is the understanding of the Company that prior Commission approval is not required for the proposed name change. Therefore, absent receipt of written notification to the contrary, the Company will, within thirty (30) days, proceed on the understanding that no approval or other formal action with respect to the name change is required.


