### DISCUSSION OF ISSUES

**ISSUE 1:** Should the Commission suspend Tampa Electric Company's (TECO) proposed tariff filed as part of TECO's petition for approval of a Pilot Green Energy Rate Rider and Program?

**RECOMMENDATION:** Yes. The Commission should suspend TECO's proposed tariff revision. (Colson)

**STAFF ANALYSIS:** Pursuant to Rule 25-17.015, Florida Administrative Code, TECO filed a petition on June 8, 2000, for approval of a Pilot Green Energy Rate Rider and Program. Staff is recommending that the tariff be suspended to allow sufficient time to review the petition.

Pursuant to Section 366.06(3), Florida Statutes, the Commission may withhold consent to the operation of all or any portion of a new rate schedule, delivering to the utility

requesting such increase, within 60 days, a reason or written statement of good cause for doing so. Staff believes that the reason stated above is good cause, consistent with the requirement of Section 366.06(3), Florida Statutes.
