REQUEST FOR CONFIDENTIAL CLASSIFICATION

Bell Atlantic Network Data, Inc. ("BAND"), by and through undersigned counsel, pursuant to Section 364.183, Florida Statutes, and Florida Administrative Code Rule 25-22.006, requests that the Florida Public Service Commission (the "Commission") classify as confidential the unaudited balance sheets and income statements contained in Composite Exhibit "C" to BAND's application for authority to provide alternative local exchange service within the state of Florida (the "ALEC Application"). In support of its request, BAND states:

1. BAND is filing contemporaneously herewith its ALEC Application. Section 364.337, Florida Statutes, states that: "The [C]ommission shall grant a certificate of authority to provide alternative local exchange service upon a showing that the applicant has sufficient technical, financial, and managerial capability to provide such service in the geographic area proposed to be served . . . ." § 364.337(1), Fla. Stat. (1999) (emphasis added). Thus, BAND is required to show that it has the financial capability to provide alternative local exchange service in Florida before the Commission can grant it a certificate of authority to provide such service. For financial purposes, BAND is relying on Bell Atlantic Financial

Services, Inc. ("BAFSI"), a wholly-owned subsidiary of BAND's parent company, Bell Atlantic Corporation.

2. Composite Exhibit "C" to the ALEC Application contains BAFSI's unaudited balance sheets and income statements, which constitute proprietary confidential business information. Therefore, BAND requests that the Commission treat as confidential the unaudited balance sheets and income statements in Composite Exhibit "C".

3. The unaudited balance sheets and income statements in Composite Exhibit "C" are entitled to confidential classification pursuant to Section 364.183(1), Florida Statutes, and are exempt from Section 119.07(1), Florida Statutes, and Article I, Section 24(a) of the Florida Constitution. Section 364.183(3) defines "proprietary confidential business information" as:

information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public.

§ 364.183(1), Fla. Stat. (1999). Section 364.183(3) further provides that "proprietary confidential business information" includes "[i]nternal auditing controls and reports of internal auditors" and "[i]nformation relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information." § 364.183(3)(b), (e), Fla. Stat. (1999).

4. The unaudited balance sheets and income statements in Composite Exhibit "C" to BAND's ALEC Application constitute "proprietary confidential business information" within the meaning of that term as described in Section 364.183(3). The unaudited balance sheets and income statements are internal reports describing BAFSI's operating revenues, operating expenses, net income and cash flow. These documents are intended to be, and have been treated by BAFSI and BAND, as private and have not been disclosed unless disclosed pursuant to a statutory provision, order of a court or administrative body, or private agreement that provides that the information will not be released to the public. Public disclosure of the unaudited balance sheets and income statements would allow competitors to have access to information about the financial resources and stability of BAFSI and BAND. Accordingly, public disclosure of the unaudited balance sheets and income statements would irreparably harm BAFSI and BAND.

5. Attached hereto is: (a) a separate, sealed envelope containing one copy of Composite Exhibit "C" with the information for which confidential classification is requested highlighted; and (b) two edited copies of Composite Exhibit "C" on which the confidential material has been redacted. Only the redacted copies may be made available for public inspection.


6. Because all of the information on the unaudited balance sheets and income statements in Composite Exhibit "C" is confidential, with the exception of the heading, there is no basis for articulating a line-by-line justification for the confidential treatment of the information. BAND, however, has summarized the

confidential information contained in Composite Exhibit "C" in this Request for Confidential Classification.

7. BAND has good cause and justification for its request. Furthermore, confidential treatment of the unaudited balance sheets and income statements in Composite Exhibit "C" will not prejudice the Commission, or any other persons or entities that may become parties to this docket.

WHEREFORE, BAND respectfully requests that the Commission determine that the unaudited balance sheets and income statements in Composite Exhibit "C" to BAND's ALEC Application are confidential and exempt from the Public Records Act, Chapter 119, Florida Statutes, and Article I, Section 24(a) of the Florida Constitution.


