REQUEST FOR CONFIDENTIAL CLASSIFICATION

Intermedia Communications Inc. ("Intermedia"), by its undersigned counsel, pursuant to Rule 25-22.006(8)(b), Florida Administrative Code, files this Request for Confidential Classification, and in support thereof states as follows.

1. On March 17, 2000, Intermedia filed the direct testimony of Edward L. Thomas, with a claim of confidentiality pursuant to Rule 25-22.006(5), Florida Administrative Code, for Exhibit Nos. ELT-4, ELT-5, ELT-6, and ELT -7, attached thereto.

2. On June 19, 2000, Intermedia filed Post-Hearing Exhibit 20 with a claim of confidentiality pursuant to Rule 25-22.006(5), Florida Administrative Code.

3. Exhibit Nos. ELT-4, ELT-5, ELT-6, and ELT-7 were entered into the evidentiary record at hearing on June 13, 2000, as Composite Exhibit 6. Exhibit 20 was to be entered into the evidentiary record upon filing as Commissioner Deason instructed at hearing.

4. These exhibits depict Intermedia's interconnection arrangements with BellSouth Telecommunications, Inc., ("BellSouth") in Orlando, Miami, and Jacksonville, Florida, and in Atlanta, Georgia.

5. Because the above-mentioned materials describe Intermedia's telecommunications network deployment in Florida and Georgia, they are proprietary confidential business information as defined in Section 364.183(3), Florida Statutes, specifically, "trade secrets" as identified in subpart (a) and "information related to competitive interests, the disclosure of which would impair the competitive business of the provider of the information" as identified in subpart (e).


8. The original of this Request was filed with the Division of Records and Reporting and a copy was served on BellSouth on the date shown in the caption.
