- * Turn LEFT onto W Street, Turn RIGHT onto US-98 W, Turn SLIGHT LEFT onto US-98 W/FL-295 S (US-98 W/FL-295 becomes FL-295 S.)
- * Turn RIGHT onto FL-292
- * Turn RIGHT onto CR-297, Make a LEFT on LARIMER AVENUE

From Pensacola Regional Airport:

- * Start going NW on Airport Blvd towards 9th Avenue by Turning RIGHT.
- * Turn LEFT onto N. 9th Avenue.
- * Turn RIGHT onto FL-295 S. (FL-295 S becomes FL-295 S/W FAIRFIELD DRIVE.
- * Turn LEFT onto W Street.
- * Turn RIGHT onto US-98 W.
- * Turn SLIGHT LEFT onto US-98 W/FL-295 S. (US-98 W/FL-295 S becomes FL-295 S.)
- * Turn RIGHT onto FL-292.
- * Turn LEFT onto CR 297, Make a RIGHT turn on LARIMER AVENUE.
