

PROPOSED ISSUES LIST FOR ISSUE ID**

BellSouth Telecommunications, Inc., ("BellSouth" or "Company"), pursuant to Staff's Memorandum of June 22, 2000, files a proposed issues list for the Issue ID scheduled in this proceeding for July 13, 2000.

1. What traffic exchanged between carriers is subject to the reciprocal compensation provisions of Section 251 of the Telecommunications Act of 1996?
2. Should the Commission establish a compensation mechanism for traffic exchanged between carriers that is not subject to the reciprocal compensation provisions of Section 251 of the Telecommunications Act of 1996?
3. What actions should the Commission take, if any, with respect to establishing an appropriate compensation mechanism for the traffic at issue in this proceeding in light of current decisions and activities of the courts and the FCC?
4. What network components are used in transporting and terminating the circuit switched traffic at issue in this proceeding?

5. What are the costs associated with the transport and termination of the circuit switched traffic at issue in this proceeding? How do these costs vary, if at all, when:
  - A) Typical circuit-based switches are used?
  - B) Remote Access Servers (RAS) or other alternative architectures are used?
  - C) Traffic is delivered outside the originating local calling area through the use of a foreign exchange service or similar arrangement?
6. What is the appropriate mechanism for the recovery of costs associated with the transport and termination of the traffic at issue in this proceeding?
7. What are the public policy considerations, if any, of paying reciprocal compensation for traffic bound to the Internet through an Internet Service Provider on a per minute of use basis?
