NOTICE OF INTENT TO SEEK CONFIDENTIAL CLASSIFICATION

BlueStar Networks, Inc., DIECA Communications, Inc. d/b/a Covad Communications Company, and Rhythms Links Inc. (collectively, the "Data ALECs"), pursuant to Section 364.183, Florida Statutes and Rule 25-22.006, Florida Administrative Code, hereby file this Notice of Intent to Seek Confidential Classification for certain potentially confidential information of BellSouth Telecommunications, Inc. ("BellSouth"), GTE Florida Incorporated ("GTEFL"), and Sprint Florida, Incorporated ("Sprint") that is included in the prefiled Direct and Rebuttal Testimony of Terry L. Murray and the prefiled Direct and Rebuttal Testimony of Joseph P. Riolo.

The information belonging to BellSouth, GTEFL and Sprint (collectively, the "ILECs") covered by this Notice consists of information obtained from documents provided to the Data ALECs pursuant to Protective Agreements with each of the ILECs. The information covered by this Notice is information that the respective ILECs claim constitutes their proprietary, confidential business information.

Pursuant to Rule 25-22.006, the Data ALECs are furnishing herewith two redacted copies of the testimonies, and one copy on which the potentially confidential material is highlighted.

The Data ALECs are concurrently furnishing each of the ILECs with a copy of the testimonies on which the potentially confidential information belonging to that party is highlighted, and the potentially confidential information belonging to other parties is redacted.

This Notice is filed to preserve the confidentiality of this information pending the filing of a formal claim of confidentiality or a formal request for confidential classification by the ILEC to whom the material belongs. By filing this Notice, the Data ALECs do not waive their right to contend that some or all of the information in fact may not be entitled to protected status.
