**Evercom Systems, Inc. (TG225)**-This company paid \$948 in RAF, plus penalty and interest, for 1998 on September 13, 1999. This company has yet to pay their 1999 RAF.

**Evercom Systems, Inc. D/b/a/ Correctional Billing Services (TJ054)**-Per the cover letter to the RAF form, this certificate is only being used for billing and collection services under their d/b/a. The company paid the \$50 minimum payment, plus penalty and interest on September 17, 1999. This company has yet to pay their 1999 RAF.

**Invision Telecom, Inc. (TI620)**-This company transferred to Evercom Systems, per Order No. PSC-98-1133-FOF-TI, on September 15, 1998. Per the RAF system, this company has yet to pay their 1998 RAF.
