**Re: Docket No. 000610-WS, Application Regarding Service Availability Charges and Policies for Duval, Nassau and St. Johns Counties, Florida, and Petition for Approval of Regulatory Accounting Treatment by United Water Florida, Inc.**

Dear Mr. Schildberg:

We have reviewed the application, schedules and data submitted by United Water Florida, Inc. (utility) on July 25, 2000. After reviewing this information, we find that the filing does not meet the requirements of Rule 25-30.565, Florida Administrative Code. The specific deficiencies are identified as follows:

1) Rule 25-30.565(4)(g), Florida Administrative Code, requires “[a] schedule showing the number of active customers on line 90 days prior to the time of application by meter size, by customer class, and the related equivalent residential connections (ERC) as defined by Rule 25-30.515(8)” (emphasis added). Exhibit G of your application refers to Schedules W-3 and S-3 as the sources of this information; however, these schedules do not show active customers by customer class (i.e. residential or commercial), as required by the rule.

2) Rule 25-30.565(4)(i), Florida Administrative Code, requires “[a] detailed statement defining the capacity of the distribution or collection system in terms of ERCs as used in developing the proposed service availability charges.” Exhibit I of your application does not provide this information.

Your application will not be deemed filed until you have complied with the requirements of Rule 25-30.565, Florida Administrative Code. The information required to correct this deficiency should be submitted no later than September 8, 2000.
