**US LEC OF FLORIDA, INC.'S PROPOSED ISSUES**

Respondent, US LEC of Florida, Inc. ("US LEC"), submits the following list of proposed issues for hearing and decision by the Commission in this proceeding.

- ISSUE 1: Should BellSouth be required to include US LEC's logo on the cover of BellSouth's White Page and Yellow Page directories?
- ISSUE 2: Should BellSouth be required to provide US LEC's subscriber listing information ("SLI") to third party publishers? If so, under what terms?
- ISSUE 3: Do the provisions of the 1996 Act authorize US LEC to designate each Point of Interconnection ("POI") so long as US LEC's designations are technically feasible? If not, under what conditions may BellSouth designate a POI?
- ISSUE 4: What is the appropriate definition of "serving wire center" for purposes of defining transport of the parties' respective traffic?
- ISSUE 5: Having established the POI, is each party obligated to provide the facilities necessary to transport traffic from that POI to end users on its network?
- ISSUE 6: What are the appropriate rates to be paid by the parties for the transport and termination of local traffic?
- ISSUE 7: Should ISP-bound traffic be treated as local traffic for purposes of reciprocal compensation, or should it be otherwise compensated?
- ISSUE 8: Should US LEC be allowed to establish its own local calling areas and assign its NPA/NXX for local use anywhere within such areas, consistent with applicable law, so long as it can provide information permitting BellSouth as the originating carrier to determine whether reciprocal compensation or access charges are due for any particular call?
- ISSUE 9: Should the parties be obligated to determine and report to each other the portion of

the local minutes as determined by the Percent Local Usage ("PLU") that is actually Dial-up Internet Traffic?

ISSUE 10: Should the rate at which US LEC will be compensated for the transport and termination of local traffic include the tandem switching rate element?
