Dear Mr. Hogue:

The Division of Records and Reporting forwarded a copy of its annual request for updated reporting requirements, which your company returned with what appears to be a request for cancellation.

The regulatory assessment fee (RAF) is assessed if a certificate is active for any one day during a calendar year. The RAF is due by January 30 of each year, unless the 30th falls on a weekend, then the fee is due by the next working day, for the previous year. The effective date of a voluntary cancellation is the date that the Commission received a company's request for cancellation. In this case, the Commission did not receive your request until this year, therefore, you will owe the 2000 RAF, even if you are no longer in business or, in fact, never went into business. You must either pay the 2000 RAF or provide a date certain that it will be paid. For example, you will pay the 2000 fee within 30 days after the Commission Order is issued granting the voluntary cancellation.

Enclosed is a copy of the Commission's rule dealing with cancellations. Please respond in writing within 15 days from the date of this letter and let me know the date you will pay the 2000 fee or enclose your check for the fee (minimum \$50.00 fee).


