("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Notice of Intent to Request Specified Confidential Classification for the Review of Numbering Resources pursuant to Florida Public Service Commission ("Commission") Order No. PSC-00-0543-PAA-TP.

1. In a Memorandum dated July 10, 2000, the Staff of the Florida Public Service Commission ("Staff") will conduct an on-site review of BellSouth's numbering procedures and numbering inventory levels to access compliance with Commission Order No. PSC-00-0543-PAA-TP in Docket No. 981444-TP.

2. The information in BellSouth's response to Staff's request contains competitive business information. This information is proprietary and entails information that is clearly confidential and proprietary under Florida Statutes, Sections 364.183 and 364.24.


