By its undersigned counsel, Concentric Carrier Services, Inc. ("Concentric") hereby surrenders its authorization as granted in the above-referenced Dockets to provide facilities-based and resold local exchange and interexchange telecommunications services in the State of Florida.

Due to a change in its business plan, Concentric no longer requires the Certificates of Authority. The company has no customers in Florida, nor has it ever provided services in Florida.
