The Commission Staff has requested that Peoples Gas System ("Peoples") consent to an extension of the 60-day requirement for Commission action on the Company's tariff filing in the above docket (under the file-and-suspend statute) in connection with the Staff's need and desire to have the filing considered by the Commission at its September 5, 2000 agenda conference, rather than at its August 29, 2000 agenda conference (as presently scheduled).

Peoples hereby agrees to an extension, to and including September 5, 2000, of the 60-day requirement under the file-and-suspend statute for Commission action on the Company's tariff filing in the above docket.
