### CASE BACKGROUND

On June 23, 2000, the Commission granted preliminary intent to grant a certificate in PSC-00-1145-PPA-TX.

On July 17, 2000, the Commission received a protest to Deland Actel, Inc., being granted a certificate from the attorneys for Actel Integrated Communications, Inc., because of the similarity in names.

On July 25, 2000, the Commission received a Notice of Withdrawal of Protest from the attorneys for Actel Integrated Communications, Inc., therefore, staff recommends acknowledgment of the withdrawal of the protest and closure of the docket.
