Dear Ms. McCoy:

Per our conversation, MegsINET-CLEC, Inc. ("M-CLEC") desires the withdrawal of the certificates granted by the Florida Public Service Commission (the "Commission") to provide telecommunications services in the State of Florida.

On October 13, 1998, the Commission granted M-CLEC certificate number 5709 to provide interexchange telecommunications services in the State of Florida. Subsequently, on April 17, 1999, the Commission granted M-CLEC certificate number 6060 to provide alternative local exchange telecommunications services in the State of Florida.

Pursuant to a merger agreement, CoreComm Acquisition Sub., Inc. ("CoreComm Acquisition Sub."), a wholly-owned subsidiary of CoreComm Limited ("CoreComm"), has been merged with and into MegsINET, Inc., the direct parent company of M-CLEC. As a result of the merger, the separate corporate existence of CoreComm Acquisition Sub. has ceased and CoreComm has acquired control of MegsINET, Inc. M-CLEC survives the merger as a wholly-owned subsidiary of MegsINET, Inc. Accordingly, CoreComm has acquired control of M-CLEC through its ownership of MegsINET, Inc.

M-CLEC has never had any customers, and has never provided telecommunications services, in Florida. Thus, CoreComm will not request that the Commission transfer M-CLEC's certificates to provide local exchange and interexchange telecommunications services, and respectfully requests that the Commission withdraw M-CLEC's certificates.
