Attached is proof of the company's authorization to transact business in Florida under this name by the Secretary of State. The company has added a fictitious name.

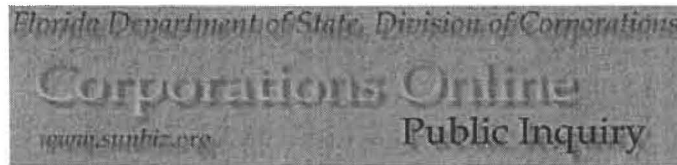
