
Please accept this letter as a request to withdraw the tariff of Cincinnati Bell Long Distance ("CBLD") and cancel its Certificate which was assigned in Docket No. 960621-TI dated May 17, 1996. This is a result of the merger of its parent company, Cincinnati Bell, Inc. with IXC Communications, Inc., parent company of Broadwing Telecommunications Inc.

The CBLD services have been merged into the Broadwing Telecommunications Inc. tariff and customers were migrated in earlier filings with the Commission. The tariff and certification of CBLD are now idle and ~~CBLD seeks to cancel its tariff and to withdraw its certification.~~ Since CBLD no longer has customers in Florida, no customers are affected by this request to cancel its authority in the state.
