
Nationwide Communications of Michigan, Inc. (Company Code TF298 and Certificate No. 3950) has authorized us to propose a settlement offer of \$750 for resolution of Docket No. 000940-TC, regarding outstanding regulatory fees and reports. As you are aware, Nationwide again failed to pay the \$50 regulatory assessment fee.

I have spoken with Bob Miller, CEO of Nationwide, and he is frustrated that this problem has reoccurred. By way of explanation, but not as an excuse, Nationwide's Florida business is truly ancillary to its Michigan business which dominates the Company's attention. Despite Mr. Miller's instructions to the contrary, somehow the Florida notices were overlooked. On information and belief, the notices were sent to the Company generally, and not to the attention of a corporate officer. Thus it is likely that the notices were misrouted. In any event, the failure to pay the \$50 regulatory assessment fee was an oversight, not intentional.


