**RE:** Docket No. 991471-TC - Initiation of show cause proceedings against J and L Communications for violation of Rules 25-4.043, F.A.C., Response to Commission Staff Inquiries, and 25-24.515(9)(a), (12), and (18), F.A.C., Pay Telephone Service.

Docket No. 000004-TC - Request for cancellation of Pay Telephone Certificate No. 3353 held by J and L Communications, and application for certificate to provide pay telephone service by Alacrity Communications, Inc.

By Order No. PSC-00-1361-PAA-TC, issued July 28, 2000, the Commission accepted J and L/Alacrity Communications' settlement offer and cancelled J and L's Certificate No. 3353 and granted a new certificate (No. 7518) in the name of Alacrity Communications, Inc. According to the Order, the company's first payment of \$466.67 was due by August 11 and the protest period ended August 18. As of this date, the Commission has not received the first installment of the \$2,800 settlement offer and according to the Case Management System, a protest has not been filed.

Staff called the telephone number for the company and left a message on its answering machine for a return call. In addition, staff attempted to fax the company a reminder note, but the fax number on file in MCD has been disconnected. The Order stated that if the company did not comply with the Order, the certificate was to be cancelled administratively. J and L's certificate became inactive August 22 and on the same date, Alacrity's became active.

Accordingly, Alacrity Communications, Inc.'s Certificate No. 7518 (TG664) should be canceled administratively. In addition, Docket No. 991471-TC should be closed. If you have any questions, please call Paula Isler at 413-6502.
