**AMENDMENT TO APPLICATION OF CITY GAS COMPANY OF
FLORIDA (A DIVISION OF NUI CORPORATION) FOR AUTHORITY
FOR NUI CORPORATION TO ISSUE AND SELL SECURITIES**

Pursuant to Chapter 25-8, Florida Administrative Code, and Section 366.04, Florida Statutes, City Gas Company of Florida ("City Gas" or "the Company"), submits this amendment to its August 9, 2000 application for authority for NUI Corporation ("NUI") to issue and sell securities, and would show as follows:

1. As a result of conversations with Commission Staff, the Company has decided to increase the dollar amount of authority it is requesting to \$125 million, in common stock, long-term debt, short-term debt, or any combination thereof.

2. The \$125 million in authority being requested will be used for the following purposes:

\$22 million -- purchase of Virginia Gas Company

\$40 million -- Virginia Gas Company storage and pipeline expansion

\$30 million -- to refinance outstanding debt of Virginia Gas Company

\$28 million -- Florida capital expansion

\$05 million -- miscellaneous, including reduction of short-term debt
