JOINT MOTION FOR EXTENSION OF TIME

Intermedia Communications Inc. ("Intermedia"), and BellSouth Telecommunications, Inc., ("BellSouth"), by their undersigned counsel, submit this Joint Motion for Extension of Time ("Motion") and in support thereof state as follows.

1. On August 22, 2000, the Commission issued its Final Order on Arbitration, Order No. PSC-00-1519-FOF-TP, in this proceeding. Therein, the Commission ordered the parties to submit a signed agreement compliant with its decisions within thirty days of the issuance of the order.
2. On or about September 20, Intermedia, with the agreement of BellSouth, made an oral request for an extension of time for filing a signed agreement until September 25, which Commission staff granted.
3. However, it later became apparent that even more time would be required.
4. Thus, the parties submit this Motion, whereby they jointly move the Commission to grant an extension of time until October 4, 2000, for the submission of a signed agreement for the Commission's approval.
