**ALLIED/CFI'S NOTICE OF WITHDRAWAL OF  
REQUEST FOR EXPEDITED RELIEF**

Allied Universal Corporation ("Allied") and its affiliate, Chemical Formulators, Inc. ("CFI"), hereinafter referred to collectively as "Allied/CFI," by and through their undersigned counsel, gives this notice of withdrawal of the request for expedited relief stated in Allied/CFI's Complaint filed on January 20, 2000, and states:

1. On September 28, 2000, Allied/CFI filed a motion for continuance of the final hearing and motion for extension of time for filing of rebuttal testimony and exhibits. Allied/CFI's motion for continuance proposes that the final hearing date of October 31, 2000 be continued to permit Allied/CFI to complete discovery concerning issues raised in documents produced to Allied/CFI by Tampa Electric Company ("TECO") on August 14, 2000 in response to Allied/CFI's initial discovery requests served on February 2, 2000, and concerning documents responsive to Allied/CFI's document request nos. 6, 7 and 8, to be produced to Allied/CFI following *in camera* inspection pursuant to Order No. PSC-00-1171-CFO-EI issued June 27, 2000.


