

("BellSouth" or "Company") hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Notice of Intent to Request Specified Confidential Classification for the Subpoena Duces Tecum Without Deposition issued by the Florida Public Service Commission (the "Commission") on October 2, 2000.

1. In the Subpoena Duces Tecum Without Deposition issued by the Commission on October 2, 2000, the Staff requested customer information that is confidential to BellSouth.

2. The information contained in BellSouth's response to Staff's Subpoena request contains customer specific and competitive business information. This information is proprietary and entails information that is clearly confidential and proprietary under Florida Statutes, Sections 364.183 and 364.24.

3. Because BellSouth's response contains proprietary information, BellSouth is filing this Notice of Intent to Request Specified Confidential Classification, pursuant to Rule 25-22.006(3), Florida Administrative Code, in
