We are writing in response to the above-referenced notice (the "Notice") by the State of Florida, Public Service Commission, Division of Records & Reporting received by Crescent Public Communications, Inc. (the "Company").

Please be advised that, the Company filed a voluntary petition for relief under chapter 11 of the United States Bankruptcy Code, 11 U.S.C. §§ 101 et. seq., on May 10, 1999, in the United States Bankruptcy Court for the Southern District of New York Case No. 99 B 10183 (AJG).

Pursuant to Section 362(a) of the Bankruptcy Code, the filing of the petition "...[o]perates as a stay, applicable to all entities, of - (1) the commencement or continuation, including the issuance or employment of process, of a judicial, administrative, or other action or proceeding against the debtor that was or could have been commenced before the commencement of the case under this title, or to recover a claim against the debtor that arose before the commencement of the case under this title" You are respectfully referred to U.S.C. § 362 and the cases decided thereunder for the entire text thereof and the scope of the stay provided for thereby.

It appears you have filed the Notice and any action related thereto subsequent to the imposition of the § 362 stay. Based upon the foregoing, we request that you immediately withdraw the Notice and any related actions and forward a copy of the notice of withdrawal to my attention.


