Dear Sir or Madam:

By this letter, ATI Telecom, Inc. ("ATI"), pursuant to the Florida Public Service Commission's ("Commission's") policy regarding name changes, hereby notifies the Commission of ATI's name change to Interoute-Wholesale, Inc. ("Interoute").

Pursuant to the Commission's Order No. PSC-97-0755-FOF-TI dated June 26, 1997, ATI is authorized to provide resold interexchange telecommunications services in the State of Florida.

As required by the Commission, the name change has been registered with the Florida Secretary of State. A copy of the Amended Certificate of Authority of a Foreign Corporation reflecting the name change issued by the Secretary of State is annexed as Exhibit A. As requested, a set of labels reflecting the new name for ATI's existing tariff is annexed as Exhibit B.

The proposed name change will have no effect on the day-to-day operations of ATI. The services currently offered by ATI to its customers will not be affected by the name change. In other words, ATI is the same company now under a different name.


