Dear Mr. Bryant:

On October 6, 2000, the Commission received your letter responding to Order No. PSC-00-1787-PAA-TC, which was issued on September 29, 2000. Your letter stated that you notified the Commission in 1998 to cancel your certificate. Unfortunately, the Commission has no record of receiving your request for cancellation.

Our records show that when you paid the \$50.00 minimum for the 1998 Regulatory Assessment Fee on February 11, 1999, you did not pay the \$2.50 penalty and \$0.50 interest (payment had to be postmarked by February 1, 1999 to avoid late payment charges), leaving a \$3.00 balance for 1998. In addition, since the regulatory assessment fee is due if a certificate is active for any day during a calendar year, and since Commission records do not show receipt of a request for cancellation in 1998, the 1999 fee, plus statutory penalty and interest charges, is owed.

Please provide the Commission a copy of your 1998 letter requesting cancellation so that it can be reviewed. I obtained a copy of the 1998 Regulatory Assessment Fee return that you mailed to us on February 11, 1999, and could not find where a notation had been made on the return that you were no longer in business.
