**JOINT NOTICE OF INTENT BY BELL SOUTH TELECOMMUNICATION, INC.  
AND SPRINT-FLORIDA, INCORPORATED TO PETITION THE FLORIDA  
PUBLIC SERVICE COMMISSION FOR APPROVAL OF TERRITORY  
TRANSFER AND CERTIFICATE AMENDMENTS**

BellSouth Telecommunications, Inc. ("BellSouth") and Sprint-Florida, Incorporated ("Sprint"), Rule 25-4.005(1), Florida Administrative Code, hereby give notice of their intention to file a Petition with the Florida Public Service Commission for Approval of a Territory Transfer and Certificate Amendment between the two companies.

1. BellSouth and Sprint will be seeking approval to transfer certain areas in Orange and Seminole Counties. Specifically, the parties will propose:
  - a. Transferring a portion of the Remington Oaks subdivision from the BellSouth Orlando Pine Hills Exchange to Sprint Winter Garden Exchange;
  - b. Transferring a portion of the Ballentyne subdivision from the BellSouth Orlando Pine Hills Exchange to the Sprint Winter Park Exchange;

- c. Transferring part of the Chain of Lakes Middle School from the BellSouth Orlando Pine Hills Exchange to the Sprint Windermere Exchange.
  - d. Transferring part of the Windermere Oaks subdivision from the BellSouth Orlando Pine Hills Exchange to the Sprint Winter Garden Exchange.
  - e. Transferring part of the Horizons at Orlando Marriott Vacation Club, Residence Inn-Horizons at Orlando, from the BellSouth Orlando Sand Lake Exchange to the Sprint Reedy Creek Exchange.
2. Sprint and BellSouth are in the process of complying with Rules 25-4.005 and Rule 25-24.004 of the Florida Administrative Code.

WHEREFORE, BellSouth and Sprint respectfully request that their Notice of Intent be acknowledged.
