MOTION FOR EXTENSION OF TIME FOR FILING TESTIMONY

AT&T Communications of the Southern States, Inc. ("AT&T"), by and through its undersigned attorney, hereby states as follows:

1. The procedural schedule in this docket requires AT&T and BellSouth to file direct testimony on November 15, 2000. (Order No. PSC-00-2083-PCO-TP issued November 2, 2000). AT&T respectfully requests that this date be moved to November 16, 2000. This extension will not have any impact on the remainder of the procedural schedule.

2. BellSouth has agreed to this extension.

3. This extension is requested due to the complexity and extent of the numerous issues to be arbitrated. Additionally, the parties' continued negotiations have resulted in settlement of some issues and further settlement discussions are in progress. The additional day will allow the parties to submit to the Commission testimony that reflects their most recent positions.

WHEREFORE, for the above-stated reasons, AT&T respectfully requests that the Commission grant an extension of time for the filing of direct testimony to November 16, 2000.


