APPLICATION FOR TRANSFER OF CUSTOMERS

Florida Power & Light Company (hereinafter "FPL") and Peace River Electric Cooperative, Inc. (hereinafter "PRECO"), hereby jointly apply to the Commission for approval of a transfer of customers pursuant to Commission Order No. 18332, dated October 22, 1987, which approved and adopted the FPL-PRECO Territorial Agreement dated July 17, 1987 (hereinafter the "Territorial Agreement"). In support of this Application, the parties further state:

3. Applicant FPL is a "Public Utility" incorporated in the State of Florida. Applicant PRECO is a "Cooperative" organized and existing pursuant to Chapter 425, F.S. Applicants are subject to the Commission's jurisdiction as set forth in Section 366.04, F.S.

4. Section 6 of the FPL-PRECO Territorial Agreement, Commission Order No. 18332, is as follows:

Section 6 - Elimination of Overlapping Services. FPL and PRECO agree to use reasonable efforts to eliminate, during the term of this Agreement, electric services by either party in the retail service areas of the other party. This effort shall include the identification of potential customer and facilities transfers which would eliminate duplication of facilities or avoid hazardous conditions. Any transfers shall be subject to review and approval by the Florida Public Service Commission.

5. FPL and PRECO jointly request the approval of the transfer of 298 PRECO customers (280 residential and 18 commercial) to FPL pursuant to Section 6 of the FPL-PRECO Territorial Agreement. The customers affected are identified in Attachment "A" hereto. The general location of these customers and the FPL-PRECO territorial boundary are identified in Attachment "B".

6. This transfer will eliminate PRECO's electric service to the identified area and the customers currently served by PRECO in FPL's service area, but will not result in a decrease in reliability of electrical service to the existing or future ratepayers of either utility.

7. The Territorial Agreement includes the following provisions:

(a) FPL has the right to purchase any existing PRECO facilities at the current net book value ("NBV"). If any facilities currently in place are not purchased by FPL, PRECO is responsible for the removal at their cost. PRECO may also request that FPL remove the facilities. If so, FPL will be fully compensated for such costs.

(b) FPL's purchase right includes any associated easements, street light contracts, franchise agreements, and joint use agreements.

(c) If during the transfer period major repairs are needed to any of the PRECO facilities FPL has agreed to purchase due to damage from a hurricane, tropical storm, tornado, etc., FPL will have the opportunity to do the repairs itself or allow PRECO to make the repairs and bill FPL for said repairs.

(d) If relocation of any existing PRECO facilities agreed to be purchased by FPL is required due to government mandate, prior to the transfer of facilities PRECO shall timely notify FPL by letter to allow for FPL to carry out the relocation.

8. (a) Each customer listed in Attachment "B" will be mailed an appropriate letter notifying them of the transfer and explaining the difference in FPL's and PRECO's rates. The letter will contain a telephone number to register approval/disapproval of the proposed transfer. PRECO will update the Commission Staff as to the responses received from affected customers pending final Commission action on the proposed agreement.


(b) Any existing customer deposits held by PRECO will be refunded to the customers. The initial deposits to FPL will be no greater than the customer's previous deposit with PRECO and can be paid over a three-month period.


9. The transfer will be scheduled to be completed within one (1) year of Commission approval of this Application.

10. FPL and PRECO represent that the proposed transfer is in the best interest of the public.

WHEREFORE, FPL and PRECO respectfully request approval of the proposed transfer of customers.


