I am enclosing herewith a copy of Miracle Communication's completed Interexchange Company Regulatory Assessment Fee Return along with a copy of the check for \$67.50, which was submitted to the Fiscal Services division, in accordance with the instructions I received from Ms. Paula Isler.

On behalf of Miracle Communications, I am requesting that the Public Service Commission maintain Miracle Communications certificate in good standing and forgive Miracle's late filing.

New management of Miracle Communication is now in place. New management has moved the principal place of business from Miracle's prior address at 20801 Biscayne Boulevard, 4th Floor, Aventura, Florida 33180, to Miracle's new address in Southern California. During that transition, a new regulatory compliance group was retained and the documents were transferred. Apparently the prior management and compliance group thought that the new management and compliance group would be addressing the annual filing fees and the new management and compliance group thought the matter had already been addressed. Sadly, this annual filing "fell through the cracks".

As you can see Miracle has conducted no business in Florida to date, and neither the Commission nor the people of Florida have been prejudiced in any way by this administrative "snafu".

Miracle Communications has advised me that all filings will now be handled by its principal office in Westlake Village, California, and future problems will be avoided.


