Please allow this letter to serve as a response to your letter of October 24, 2000. We understand that Don Burno of Integra Paging has already spoken with your office with respect to this matter, but we are providing this written follow-up per the request of your letter.

As we have previously indicated, Mr. Don Burno is the CEO of Integra Paging, and he was not aware that Integra had failed to comply with information requests by the Commission last year. Unfortunately, due to the misfeasance of one of his employees, the Commission's requests were not complied with. Mr. Burno has corrected this situation by terminating the employee who caused this situation, and has implemented procedures to insure that he will personally handle all future document requests by the Commission, and that the failure to supply the requested information will not happen again in the future. Unfortunately, the RAF which was due January 30, 2000, was not submitted until October 13, 2000.
