
Dear Ms. Bayo:

On November 15, 2000, BellSouth Telecommunications, Inc. ("BellSouth") filed its Notice of Intent to Request Specified Confidential Classification for Exhibits 1 and 2 to the Direct Testimony of the Georgetown Consulting Group, Jamshed K. Madden, Michael D. Dirmeier and David C. Newton. As noted in BellSouth's Notice, the information contained in Exhibits 1 and 2 is from Sprint PCS' cost study (Document No. 07649-00). On August 30, 2000, the Commission issued its Order No. PSC-00-1564-CFO-TP in which it granted confidential treatment of Document No. 07649-00, including the information contained in the aforementioned Exhibits 1 and 2.


