Sprint's 252(i) election of the Verizon/AT&T interconnection, resale and unbundling agreement was approved by the Commission by Order No. PSC-98-0251-FOF-TP issued February 6, 1998 in Docket No. 971159-TP. The attached amendment implements the FCC's Third Report and Order in CC Docket No. 98-147 and Fourth Report and Order in CC Docket No. 96-98, released December 9, 1999.
